REQUIRES

1. Headmistress (Upto class V)*:

E.Q.: Post-Graduation with B.Ed.

Desired Experience: Atleast ten years teaching experience as a PGT/TGT and 3 years of experience of teaching/administration in primary classes or 3 years of experience of heading a Secondary/Sr. Secondary school. Those who have atleast 15 years of experience as a PRT including 3 years administrative experience can also apply.

Note: Apart from the experience certificates of PGT/TGT, experience certificates mentioning the proof of classes taught in Primary school is a must. Those whose gross salary is less than Rs. 35,000/- per month need only apply.

2. PGT-Home Science* (freshers can also apply):

E.Q.: Post Graduation in Home Science with B.Ed.**

*Those who had applied previously need not apply again as the interviews are yet to be scheduled.

**Though B.Ed. is essential, if any candidate without B.Ed. applies and is shortlisted for appointment, after interview will receive an Ad hoc appointment.

Age (Not applicable to internal candidates): below 50 years for Sl. No. 1, below 40 years for Sl. No. 2.

Age criterion: Please note that the desired experience asked for is a part of the age limit given for a particular post.

Example: Age of a candidate is 40 years

Desired relevant experience asked for = 3 years

Age limit = 35 years (3 years desired relevant experience is included in this. No age benefit for those having 3 years of desired relevant experience.

Case A

- (a) Candidate has desired relevant experience of 5 years
- (b) Age benefit = $5 - 3 = 2$ years
- (c) Is candidate eligible for further scrutiny?
 $40 - 2 = 38$ years which is more than 35 years, so candidate is not eligible for further scrutiny.

Case B

- (a) Candidate has desired relevant experience of 10 years
- (b) Age benefit = $10 - 3 = 7$ years
- (c) Is candidate eligible for further scrutiny?
 $40 - 7 = 33$ years. Yes, the candidate is eligible for further scrutiny.
